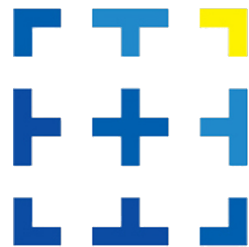

The Project Results

- A MEUSAC Action Plan 2020-2023
- Increased awareness on the importance of stakeholder participation
- **18** persons gaining a certification in communication tools, EU project management and stakeholder engagement
- **720** hours of training to **60** different stakeholder organisations
- **60** participants from different stakeholder organisations delivering ESF related policies gaining a certification on stakeholder engagement.
- Increase stakeholder participation in social dialogue
- Increase in **10%** in the average number of participants in consultations sessions
